6. In case of cancellation, a 24 hour minimum notice

Must be ordered and paid for 2 weeks in advance of event. You must provide your own table and chairs.*

## **Arts and Crafts and Commercial Vendor Requirements of the State of California, County of Lake and City of Lakeport**

The State requires all vendors to have a “Sellers Permit” and collect sales tax on taxable items. Currently, in the City of Lakeport, the tax is 8.75%. The Sellers Permit can be obtained, free of charge, from the State Board of Equalization. Use web site [www.cdtfa.ca.gov](http://www.cdtfa.ca.gov) for this information.

The City of Lakeport requires a “One Day Business License” for vendors who are not already licensed by the city. The cost of this license is \$14. On line: [www.cityoflakeport.com](http://www.cityoflakeport.com). Click on “Business Licensing” on the bottom of the page, click on “complete the appropriate form”, click on “One Time Business License” form BL-02 and print form. City Hall is located at 225 Park St., Lakeport, 95453.

If you are a FOOD Vendor selling eat on site food or processed food items, you will need a “Temporary Health Permit” from the Environmental Health Division of Lake County. They are located at: 922 Bevins Court, Lakeport, 95453. Online: [www.co.lake.ca.us](http://www.co.lake.ca.us). Click on “Department Directory”, scroll down and click on “Environmental Health”, click on “Temporary Food Event Application” and print form.

Both the City and the County representatives were at our event last year checking for permits and health requirements.
